

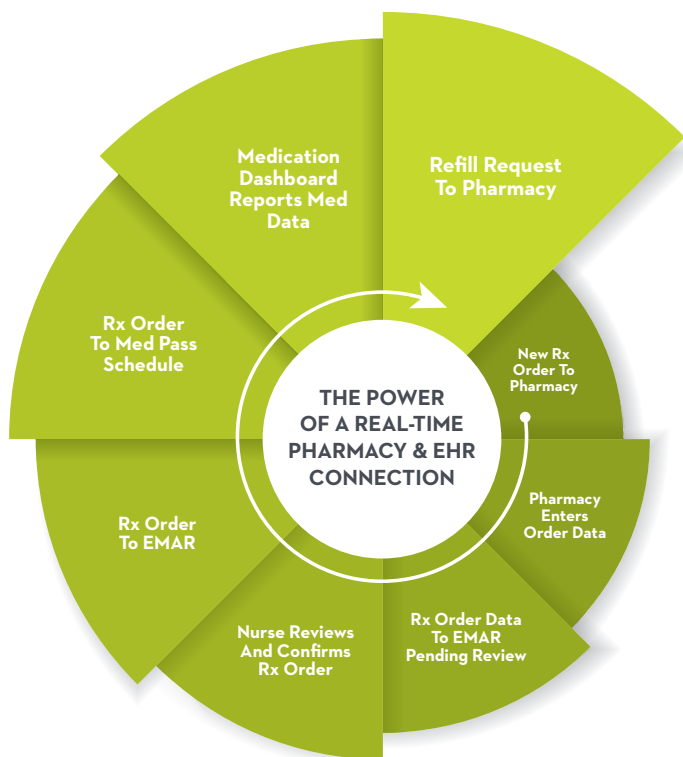

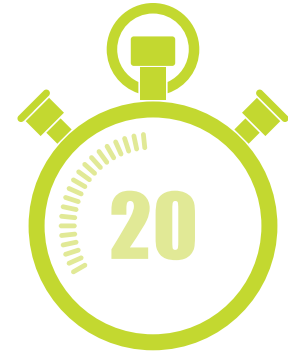
- Eliminates month-end reconciliation workflow

- Aids in clinical Quality Assurance & Quality Improvement initiatives

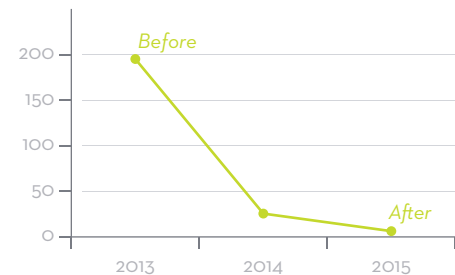
